**RECEIVER’S ADDITIONAL SCHEDULES OF PAYMENTS TO BE MADE  
PURSUANT TO THE 1ST, 2ND, 3RD, 4TH, AND 5TH INTERIM PLANS**

Receiver Ralph S. Janvey (the “Receiver”) hereby files the following Additional Schedules of Payments to be Made Pursuant to the 1st, 2nd, 3rd, 4th, and 5th Interim Plans:

**I. 19th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 1st Interim Plan.**

On May 30, 2013, the Court granted the Receiver’s Motion for Approval of Interim Distribution Plan (the “1st Interim Plan”). [See Doc. 1877.] The Court’s Order approving the 1st Interim Plan instructed the Receiver as follows:

Payments under the Interim Plan shall be made on a rolling basis as certifications in response to Certification Notices are received and processed. Prior to making a group of payments pursuant to the Interim Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 8.] The Receiver is filing the 19th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 1st Interim Plan (which is attached hereto as **Exhibit 1**) in accordance with the above instructions and expects to begin the process of sending

the payments listed therein once the 19th Schedule has been on file with the Court for ten (10) days. This 19th Schedule shows that the Receiver intends to make payments totaling \$177,574.33 to the owners of the referenced claim numbers. This 19th Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis.

**II. 10th Schedule of 0.39% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 2nd Interim Plan.**

On July 2, 2014, the Court granted the Receiver's Motion for Approval of Second Interim Distribution Plan (the "2nd Interim Plan"). [See Doc. 2037.] The Court's Order approving the 2nd Interim Plan instructed the Receiver as follows:

Payments under the 2nd Interim Plan shall be made on a rolling basis. Prior to making a group of payments pursuant to the 2nd Interim Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 5.] The Receiver is filing the 10th Schedule of 0.39% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 2nd Interim Plan (which is attached hereto as **Exhibit 2**) in accordance with the above instructions and expects to begin the process of sending the payments listed therein once the 10th Schedule has been on file with the Court for ten (10) days. This 10th Schedule shows that the Receiver intends to make payments totaling \$153,106.41 to the owners of the referenced claim numbers. This 10th Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis.

**III. 6th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 3rd Interim Plan.**

On March 22, 2016, the Court granted the Receiver's Motion for Approval of Third Interim Distribution Plan (the "3rd Interim Plan"). [See Doc. 2288.] Funds distributed

under the 3rd Interim Plan include funds from the A&R Settlement<sup>1</sup>, the BDO Settlement<sup>2</sup>, and other Receivership assets. [See Doc. 2275 at 1-2 (Receiver’s Motion for Approval of 3rd Interim Plan).] The Court’s Order approving the 3rd Interim Plan instructed the Receiver as follows:

All payments under the Third Interim Distribution Plan shall be made on a rolling basis. Prior to making a group of payments pursuant to the Third Interim Distribution Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 5.] The Receiver is filing the 6th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 3rd Interim Plan (which is attached hereto as **Exhibit 3**) in accordance with the above instructions and expects to begin the process of sending the payments listed therein once the 6th Schedule has been on file with the Court for ten (10) days. This 6th Schedule shows that the Receiver intends to make payments totaling \$392,580.57 to the owners of the referenced claim numbers. This 6th Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis.

**IV. 4th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 4th Interim Plan.**

On May 16, 2017, the Court granted the Receiver’s Motion for Approval of Fourth Interim Distribution Plan (the “4th Interim Plan”). [See Doc. 2520.] Funds distributed

under the 4th Interim Plan include funds from the Kroll Settlement<sup>3</sup>, the Chadbourne Settlement<sup>4</sup>, and other Receivership assets. [See Doc. 2520 at 3, 5-6.] The Court's Order approving the 4th Interim Plan instructed the Receiver as follows:

All payments under the Fourth Interim Distribution Plan shall be made on a rolling basis. Prior to making a group of payments pursuant to the Fourth Interim Distribution Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 5.] The Receiver is filing the 4th Schedule of 1.00% Payments to Be Made to Eligible Receivership Investor CD Claimants Pursuant to the 4th Interim Plan (which is attached hereto as **Exhibit 4**) in accordance with the above instructions and expects to begin the process of sending the payments listed therein once the 4th Schedule has been on file with the Court for ten (10) days. This 4th Schedule shows that the Receiver intends to make payments totaling \$393,846.19 to the owners of the referenced claim numbers. This 4th Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis.

**V. 2nd Set of Schedules of Payments to Be Made Pursuant to the 5th Interim Plan.**

On November 19, 2018, the Court granted the Receiver's Motion for Approval of Fifth Interim Distribution Plan (the "5th Interim Plan"). [See Doc. 2805.] The Court's Order approving the 5th Interim Plan instructed the Receiver as follows:

All payments under the Fifth Interim Plan shall be made on a rolling basis. Prior to making a group of payments pursuant to the Fifth Interim Plan, the Receiver shall file a schedule of the payments to be made. Each such schedule shall be filed at least ten (10) days prior to the subject payments being made. The schedules shall include claim ID numbers and the amount of the associated payments but shall not contain information from which the individual Investor CD Claimants can be identified.

[*Id.* at 7.] Accordingly, the Receiver hereby files the five Schedules described below and attached hereto.

**A. Schedules Reflecting 3.39% in Catch-Up Payments to Eligible JL Investor CD Claimants.**

The 5th Interim Plan authorized the Receiver to issue 3.39% in catch-up pro rata distributions to eligible JL Investor CD Claimants under the 1st through 4th Interim Plans. [See *id.* at 3-4.] For purposes of such catch-up distribution payments, the same procedures, methodologies, and requirements as those set forth in the Orders approving those four Interim Plans apply, and the Receiver was ordered to use the assets previously approved by the Court to fund those four distributions. [See *id.* at 3.] Accordingly, attached hereto are the following four Schedules:

- **Exhibit 5** – 2nd Schedule of 1.00% Catch-Up Payments to Be Made to Eligible JL Investor CD Claimants Pursuant to the 1st Interim Plan. This Schedule shows that the Receiver intends to make payments under the 1st Interim Plan totaling \$134,594.64 to the owners of the referenced claim numbers.
- **Exhibit 6** – 2nd Schedule of 0.39% Catch-Up Payments to Be Made to Eligible JL Investor CD Claimants Pursuant to the 2nd Interim Plan. This Schedule shows that

the Receiver intends to make payments under the 2nd Interim Plan totaling \$52,491.89 to the owners of the referenced claim numbers.

- **Exhibit 7** – 2nd Schedule of 1.00% Catch-Up Payments to Be Made to Eligible JL Investor CD Claimants Pursuant to the 3rd Interim Plan. This Schedule shows that the Receiver intends to make payments under the 3rd Interim Plan totaling \$134,594.64 to the owners of the referenced claim numbers.
- **Exhibit 8** – 2nd Schedule of 1.00% Catch-Up Payments to Be Made to Eligible JL Investor CD Claimants Pursuant to the 4th Interim Plan. This Schedule shows that the Receiver intends to make payments under the 4th Interim Plan totaling \$134,594.64 to the owners of the referenced claim numbers.

The Receiver expects to begin the process of sending the payments listed in the above-referenced Exhibits 5 through 8 after those four Schedules have been on file with the Court for ten (10) days. These four Schedules will be followed by others, each of which will be submitted by the Receiver on a rolling basis.

**B. Schedule Reflecting Additional 1.11% Payments to Eligible Investor CD Claimants.**

The 5th Interim Plan also approved an additional 1.11% pro rata distribution from the Receivership to all eligible Investor CD Claimants (including both to Receivership Investor CD Claimants and to JL Investor CD Claimants), to be made from the Hunton Settlement<sup>5</sup>, the Swiss Assets<sup>6</sup>, and other Receivership Assets. [See Doc. 2805 at 4-6.] Accordingly, attached hereto as **Exhibit 9** is the 2nd Schedule of 1.11% Additional Payments to Be Made to Eligible Investor CD Claimants Pursuant to the 5th Interim Plan, which Schedule shows that the Receiver

intends to make payments totaling \$774,830.74 to the owners of the referenced claim numbers. The Receiver expects to begin the process of sending the payments listed in that Schedule after it has been on file with the Court for ten (10) days. This Schedule will be followed by others, each of which will be submitted by the Receiver on a rolling basis.
